

End User License Agreement for SeqTrial Software

This End User License Agreement ("Agreement") is between **Scott S. Emerson, M.D., Ph.D.** ("Licensor") and you (an individual, or if you are licensing the SeqTrial software ("Software") as part of your job responsibilities, the company for which you work) ("You"). The following terms shall govern Your use of the Software.

1. **License Grant.** The Software is the property of Licensor or its licensors and is protected by copyright and other laws. While Licensor and its licensors continue to own the Software, Licensor hereby grants to You a limited, non-transferable, non-exclusive, license to use the Software, in machine-readable, executable code form and solely for Your own internal business use.
2. **Restrictions.** You agree not to (a) make copies of the Software other a reasonable number of backups; (b) provide access to the Software to anyone other than employees, contractors, or consultants under written contract with You agreeing to be bound by terms at least as protective of Licensor as those in this Agreement; (c) sublicense, transfer, assign, distribute to any third party, pledge, lease, rent, or commercially share the Software or any of Your rights under this Agreement (for the purposes of the foregoing a change in control of You is deemed to be an assignment); (d) use the Software for purposes of providing a service bureau, including, without limitation, providing third-party hosting, software-as-a-service ("SaaS"), cloud offering, or third-party application integration or application service provider-type services, or any similar services; (e) use the Software in connection with ultrahazardous activities, or any activity for which failure of the Software might result in death or serious bodily injury to You or a third party; or (f) directly or indirectly, in whole or in part, modify, translate, reverse engineer, decrypt, decompile, disassemble, make error corrections to, create derivative works based on, or otherwise attempt to discover the source code or underlying ideas or algorithms of the Software.
3. **No Support.** Licensor will not provide any maintenance or support for the Software. You have no right to receive any upgrades, patches, enhancements, bug fixes, new versions or new releases of the Software.
4. **Audit.** You grant Licensor and its independent auditors the right to audit Your compliance with this Agreement.
5. **Copies.** The Software is the copyrighted property of Licensor or its licensors and is protected by copyright and other laws. You may not copy or transfer to a third party any Software or documentation except as expressly authorized in this Agreement. You shall include all copyright, trademark and other notices and legends on all copies of Software and related documentation. Portions of this Software are the copyrighted material of TIBCO Software Inc.
6. **Disclaimer of Warranty.** THE SOFTWARE IS PROVIDED "AS IS". ALL EXPRESS OR IMPLIED CONDITIONS, REPRESENTATIONS AND WARRANTIES INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NONINFRINGEMENT, SATISFACTORY QUALITY OR ARISING FROM A COURSE OF DEALING, USAGE, OR TRADE PRACTICE, ARE HEREBY EXCLUDED BY LICENSOR AND ITS LICENSORS TO THE EXTENT ALLOWED BY APPLICABLE LAW. NO WARRANTY IS MADE REGARDING THE RESULTS OF THE SOFTWARE OR THAT THE SOFTWARE WILL OPERATE WITHOUT ERRORS, PROBLEMS OR INTERRUPTIONS, OR THAT ERRORS OR BUGS IN THE SOFTWARE WILL BE CORRECTED, OR THAT THE SOFTWARE'S FUNCTIONALITY WILL MEET CUSTOMER'S REQUIREMENTS. NO LICENSOR DEALER, DISTRIBUTOR, AGENT OR EMPLOYEE IS AUTHORIZED TO MAKE ANY MODIFICATIONS, EXTENSIONS OR ADDITIONS TO THIS DISCLAIMER OF WARRANTY.
7. **Limitation of Liability.** IN NO EVENT WILL LICENSOR OR ITS LICENSORS BE LIABLE FOR ANY LOST DATA, LOST REVENUE, LOST PROFITS, DAMAGE TO REPUTATION, BUSINESS INTERRUPTION, OR ANY OTHER INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, PUNITIVE, EXEMPLARY OR ANY SIMILAR TYPE DAMAGES ARISING OUT OF THIS AGREEMENT, THE USE OR THE INABILITY TO USE THE SOFTWARE, EVEN IF LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT SHALL DAMAGES, WHETHER ARISING IN CONTRACT, TORT (INCLUDING ACTIVE OR PASSIVE NEGLIGENCE),

BREACH OF WARRANTY, CLAIMS BY THIRD PARTIES OR OTHERWISE, EXCEED THE LICENSE FEE PAID BY CUSTOMER FOR THE SOFTWARE.

8. THE FOREGOING LIMITATIONS SHALL APPLY EVEN IF THE ABOVE-STATED REMEDY OR LIMITED WARRANTY FAILS OF ITS ESSENTIAL PURPOSE. BECAUSE SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATION OR EXCLUSION OF CONSEQUENTIAL OR INCIDENTAL DAMAGES, THE ABOVE LIMITATION MAY NOT APPLY TO YOU.
9. Export. The Software, including technical data, is subject to U.S. export control laws, including the U.S. Export Administration Act and its associated regulations, and may be subject to export or import regulations in other countries. You agree to comply strictly with all such laws, and shall obtain any export, re-export, or import authorizations required by the United States or other applicable jurisdictions. You represent and warrant that You are not located in any U.S. embargoed country, under control of, or a national or resident of any such country or on the U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Department of Commerce Denied Persons List or Entity List.
10. Authority. You hereby represent and warrant that You have full power and authority to accept the terms of this Agreement on behalf of You, and that You agree to be bound by this Agreement.
11. Term and Termination. This Agreement is effective until terminated. Licensor may terminate this Agreement immediately if You breach this Agreement to any extent. Upon termination or Your rejection of the Software, You will, at Licensor's option, return or destroy the Software and documentation and shall promptly certify Your compliance with the foregoing in writing.

12. General. If any portion of this Agreement is found to be void or unenforceable, the remaining provisions shall remain in full force and effect. This Agreement shall be governed by and construed in accordance with the laws of the State of Washington, United States of America, as if performed wholly within the state and without giving effect to the principles of conflict of law. The United Nations Convention on Contracts for the International Sale of Goods is excluded from application hereto. If any portion hereof is found to be void or unenforceable, the remaining provisions of this Agreement shall remain in full force and effect. The relationship of Licensor and You established by this Agreement is that of independent contractors, and not principal/agent, employer/employee, partners or joint venturers.
